Discussion:

Parliamentarian Erwin: Like Speaker Wilson, Jack was one of the first people I met when joining this organization. He is the one who first explains what it means to be a senator, how it functions, and it was him who inspired me to eventually run for a position on Senate leadership. So, I'll be very grateful to Speaker Fadness, like to many others, he shaped my future in this org and I will always be very close to him for that.

Sen. Carter: Speaker Fadness was the Speaker when I first joined back after I took my

leave of absence. He was the first person to reach out and just make sure everything was okay and everything. In my opinion, Jack deserves this. I mean, I've known Jack through Greek Life, he's currently serving as Vice President of the Tau Kappa Epsilon Fraternity, Jack deserves this.

Sen. Punzel: Even though I never met him, he seems like an awesome man. When reading his accomplishments, why don't we recommend him for emeritus? These seem like great accomplishments that are hard to achieve.

Advisor Bilgen: That's the purview of the body, if anyone feels like that should be bestowed I would encourage you to make a motion to amend the resolution.

Sen. Punzel motions to amend the resolution to make him an emeritus member Seconded by Sen. Beasley.

Discussion on motion:

SUFAC Chairman Emeritus Schweinert: Thinking of Mr. Fadness, going back some years now, he definitely carried himself in a way that Isaiah put it, often the last to speak. Jack had a great impact on this campus and all of the events that we worked on. But, going to the point of Emeritus, I think it's definitely a very reasonable amendment to make for Mr. Fadness, but I also would question you and ask what his most significant accomplishment was and what that impact is today. I think oftentimes that is a question that I would pose if I was voting on such a matter of Emeritus. If you can list those, that is great, but you might not be able to, and I'm not discouraging a vote for it, but I would just ask yourself what those are and to proceed after thinking carefully about that, and not just rushing into making someone Emeritus because it sounds like a good idea right now.

Advisor Bilgen: One of the things I would attribute to Jack, is a very cool head in the face of people questioning process very cooly and fairly. There are several very late night opportunities for him to share his leadership, number crunching, working on parking. That was a joint effort, not only Emeritus Director Robinson and former President Izzo, that typically Speakers would not have been involved with.

Parliamentarian Erwin: Point of order, content changes closed before the amendment was moved, so we are not able to consider the motion to amend it to emeritus status.

Deputy Speaker Petreikis: A motion was made, and was seconded, which can be done at nearly any time. The way I interpreted it, and the way I am running it is that a motion can be made in the discussion, then seconded, go into discussion on the motion, then if it passes it needs to be passed by a majority.

Deputy Speaker Petreikis: I am very fortunate for the time I spent with Speaker Fadness, Jack, he was in the org before me. We spent a lot of time working together. However, I think emeritus is a step above, and I can't really think of anything particular that he did. I don't know how I can politely say this. I'm thankful for the time I spent with Jack.

Speaker Wilson: I liked the time I spent with Jack. But, I think that emeritus status has had so many silly conversations. This is the way I really feel right now. I think, in terms of emeritus status, it has been seen in many different ways. It gives the ability to have you recognized when walked into a room, gives you speaking privileges during meetings, but overall it is a big thank you. I would encourage the body to vote aye. I think that is what

emeritus is now.

Parliamentarian Erwin: Now that the standing rules questions have been resolved, I would like to say that Speaker Fadness has had a notable time in the Senate. He formed many Senate and EBoard careers for people in the org. He helped shape much of Senate Leadership as well. He is a significant figure, who is well deserving of honoring, but emeritus status is meant to confer exceptional service, not just exemplary. So while he was very notable, I would caution the Senate on voting aye for this amendment. On this piece of legislation is many people who worked closest with Speaker Fadness, and they felt the best thing for this is a honoring legislation. We can give this status to very few people every academic year.

Sen. Wiitanen: I think, personally, as a person who has written an emeritus bill in the past, honoring bills are used to show honor and things in the org, while the emeritus bills are more directed towards the legacy of change. He did good work, but I don't think he earned the status.

Sen. Kelleher: I have a question for those who knew him. What is a lasting impact he did? What did Director Emeritus Robinson, Speaker Emeritus Wesolek, SUFAC Chairman Emeritus Schweinert do to create lasting impacts that helped them earn the emeritus status?

Speaker Wilson: I think, to speak to a couple of the names, Speaker Emeritus Wesolek served for half a decade to the University. Governor Evers appointed him to the board for disability concerns. Director Emeritus McNeilly, and Chair Emeritus Schweinert were a part of establishing the non-allocable leadership team, which allows for student representation. It gives students more representation for student dollars. If your question is how do we measure those people to former Speaker Fadness, I plainly don't think he measures up, but this is just how I think it is now.

Sen. Punzel: So from hearing from some people, some of his efforts are still being felt today, such as campus parking. He also had direct impact on the student body as well, being a peer mentor. We are about helping the student body.

SUFAC Chairman Emeritus Schweinert: I believe that you bring up a great point, but the question that goes back to the body, is what impacts the students. There are a lot of things that you can do that will impact the students for a long time, but is it one thing, two, five, ten? You can do great things outside of student government to help impact campus, but is there something specifically in student government which allows emeritus. As one of the people who helped established emeritus, it's to go to just a few.

Speaker Wilson: One point the body should recognize, if we're going to confer emeritus status is the way that the amendment was made was emeritus member. We would need to decide on Senator Emeritus or Speaker Emeritus, as well as change the final line to reflect the status. Also, the title.

Advisor Bilgen: It's 12.5 for those following along at home.

President Bradley: If this were to pass, I would be looking for a motion to remove my name from the legislation.

Deputy Speaker Petreikis: A vote of aye is to adopt emeritus status, a vote of nay is to not

Discussion:

Vice Chair Nicole Kuhnz: Every time we would be in a meeting he would always give a hot dog or a howdy. Every time he started a conversation or a text it would be like howdy folks. Or a hot dog.

Advisor Bilgen: I would just share that there have been some situations presented to NALT this year, and the committee have grappled over, and as the elected leader of that group Chase has worked over the summer, over semester break, and stood on firm ground with some people when people were doing things they should not do with their money. That is not an easy place to be. When you are in the room with upper leadership, and calling them to task on their delivery of expectations by the students in a professional matter, I have not seen that done with such nimbleness, so much ethics and so much with students in mind. I can't speak to everything Chase has done, but I think that was a service to students which was exceptional, especially int eh past year, so thank you Chase, for the advocacy, proper spending, and we will leave it at that.

Sen. Houston: I have had the pleasure of meeting Chase last semester, if I could describe him in two words the first one would be leadership, he provides outstanding leadership along with Nicole. He is very knowledgeable. He provides great leadership. The second word would be humor, as he is very funny. He is very deserving of this.

Vice President Boehm: I'm not sure where I first met Chase, but I heard of his help with WSG. He also served as convener for our NALT team, that is not taken lightly. Any time I wondered what was going on he would come in, take me by his wing, and carry me to the sunset. Other than that, I have hung out with this man in a more of a social setting, and you can't get him to stop talking about NALT or SUFAC. I think that speaks volumes about his dedication and commitment about his responsibilities.

Director Smith: I've known Chase a long time. Through the past four years I have had such a privilege working with him. We were in ULead together, and then in WSG. I believe that the impact Chase has had through student government, as well as the SUFAC process, and the growth and curiosity that he models for students is incredibly impressive. I'm inspired by his drive to serve students in the best way that he can. I'm certain that throughout these four years, Chase has had plenty of opportunities, as have I, to endure hardships and learn from them. Chase is someone who carries this learning with grace, and in a way I hope to emulate myself. I remember having a conversation with him about a year or so ago, when he asked me my perspective on campus and campus safety. He purposely reached out to me as our perspectives are very different. Chase has made a point to increase accessibility to the SUFAC process. He wants to help every student. When I first read this legislation, it was one that granted Chase emeritus status. I believe that he deserves that and would encourage you all to consider it.

Sen. Carter: Chase has done so much amazing stuff on this campus, I have known Chase probably as long as Director Smith has. I saw him in another position, as homecoming Chair. I would go into the office and he would be locked in and working away. He does everything for the students. I wish him nothing but the best. Chase, if there was a picture of you in the dictionary, it would probably be leadership.

Director Reiser: Two years ago, when I was first coming into WSG, it was actually you and Doug who welcomed me as I walked up the stairs. You are very welcoming, a great leader, and very well spoken. That is a part of the reason you can advocate so well.

Sen. Punzel: Knowing Mr. Zimmerman personally, he is an amazing leader. I would like to motion to revisit content changes and change to emeritus status. Seconded by Deputy Speaker Petreikis.

Sen. Punzel: One thing we need to acknowledge, being the SUFAC chair is probably one of the hardest jobs on campus. He has done it flawlessly. Also, handling NALT, being the convener, is one of the most important positions on campus. So, I would recommend a vote in favor of upgrading him to Emeritus status.

Sen. Wiitanen: Point of Clarification, what would the title look like? What would we be granting Emeritus to?

Sen. Punzel: Chairman Emeritus of SUFAC.

Sen. Wiitanen: I would encourage a vote of aye, as he has worked hard. He doesn't take his job lightly.

Parliamentarian Erwin: I would highly encourage a vote of nay. We just decided that to be emeritus you would need to be completely remarkable and memorable. I would like to read a bit of the last SUFAC Chair's bill. What in that legislation is different than Mr. Zimmerman's legislation? I don't see a great deal of different. I don't deny that he has been a successful SUFAC Chair but I do deny that he has been an Emeritus worthy SUFAC member. His work is comparable to the past chair. He deserves a bill honoring him, nothing grander.

Deputy Speaker Petreikis: I wrote both bills. I believe Katie was a great chair, I think Chase is just that much better. I think out of all of these bills we will see tonight, or this semester, the only person I think is worthy of Emeritus is Chase.

SUFAC Vice Chair Nicole Kuhnz: Not only as SUFAC Chair, he has not only done great things on this campus. But, he has also done great things statewide. I won't get into it specifically. But, he has spoken to governors and others, and has done great. He has quite literally changed the future of SUFAC.

Sen. Wiitanen: I would like to say, as I was reading this bill, Parliamentarian Erwin asked did you read it? What stuck out to you? I have to say the fourth Whereas. Where it says, convener of NALT, I had to google that word. It means lead. We will hear his name at least twelve times each semester during these meetings, saying do you remember Chase Zimmerman's work? That is what earns someone the status of emeritus. I would encourage a vote of aye.

SUFAC Chairman Emeritus Schweinert: I think it is important to avoid words being used, such as remarkable or exceptional, but really consider what this individual has done. Beyond leading a body, which is what they get paid to do, that is a great duty. That deserves recognition. What must be considered, what has changed, what has made a big impact to the student body going forward? Leading a body doesn't constitute emeritus. That is their job, the duty they have taken. I would challenge the body to think about this.

Sen. Boll: A point I heard earlier, is do we see growth from one chair to another, we can't just give emeritus because of that.

President Bradley: I think Chase is very deserving of the Emeritus title, and those knowing my history with him, and our history together, that means a lot. I think this body should decide who deserves this status.

Parliamentarian Erwin: I want to go back to the past resolution voted on, Speaker Fadness has very similarly been a great leader, he led a body. He also held other roles. He also held other things beyond the realm of the Speaker role. I believe his bill is very similar to Mr. Zimmermans. There isn't anything here to draw a distinction between this ledge and other pieces of honoring ledges. He has a SUFAC Chair who served successfully, who should be thanked with an honoring bill.

Sen. Kelleher: Going off of Parliamentarian Erwin, I think that the vote we made recently, we used the logic of what did the individual do that changed the landscape. What will be remembered for years?

Deputy Speaker Petreikis: I don't know how many of you have a packet from last week, but we had a NALT meeting a couple weeks ago, and that is because of Chase. I can't talk about what was discussed there, but there were issues found in NALT, severe issues and critical, that were not really on the radar last year but are number one on our priority list this year. It will continue to be in the stop three for the next decade I'd assume.

Sen. Punzel: The constant mention of how we voted last time should not be brought up, we are humans and can think for ourselves. Yes, as him being recognized for emeritus as the chair of SUFAC, his other contributions to the student body should not be overshadowed. He was Homecoming Chair, ULead Co-Coordinator, Warhawk Ambassador, Senator, Deputy Speaker, and even being the Vice Chair of arguably one of the most important committees we have at this moment.

Vice President Boehm: I have two more things, before we move to vote, Chase was not only a leaders, who not only inspired myself, but many others in this meeting. The second thing to note, is that with many people saying that you need change for this title, but you typically don't see changed right away. It begins with a little spark. He has begun that spark.

Speaker Emeritus Wesolek: As I sit two seats away from the last Chairman Emeritus Schweinert, he was instrumental in creating the NALT process. Convener was his word. He is the one who changed it from the President. He fundamentally changed the process. It had it's benefits. I can count numerous changes the last Chairman made. When emeritus status was made, we looked at people who changed the landscape. We looked at Tom Kind, who restructured much. There are a lot of different ways people have changed the landscape. Your job is to decide, is an individual member deserving of that?

Director Smith: Emeritus has been given to people who have led bodies before, much of their accomplishments are in part of people they lead. Chase has advocated on a statewide level, to ensure that student organizations who would not receive funding would receive it. You don't see that from a SUFAC Chair. He advocated for those students. He advocated that the first amendment protected those students. Please consider that as something substantial and impactful to you and your peers.

Sen. Wiitanen: I make a motion for a five minute recess.

Seconded by Sen. Esterholm

Sen. Wiitanen: Just to take a break, think, there's been a lot of thoughts in this moment.

Director Smith: I would remind you all, that if you're unsure at this time, you can table legislation. I'm not saying that you should, but you can do that.

Parliamentarian Erwin: Tabling is usually a way of removing a bill from consideration. If you would like to make a new bill, then you can do so. If you would like more time to consider, you should postpone.

Sen. Carter: Point of information, if you vote on this bill right now, can we go back to it in the future and change it to emeritus?

Advisor Bilgen: If emeritus status is in this bill or not, it is four fifths to remove it. There is a process. General principle and practice, if you vote today and you get another piece of information, you can ask the speaker to bring it back up.

Sen. Kyriakopoulos: I think it is important to look at this list that we have in front of us, of everything Chase has done himself. On top of that, as Director Smith has mentioned, he has advocated for multiple organizations to get the funding they deserve. Even though that may not mean much to you, that means everything to those organizations and for that reason he deserves this.

Sen. Boll: Something previously stated that this was originally an emeritus bill and then it was brought to a standard honoring bill.

Sen. Punzel: Sen. Boll, I would like to mention, even though this was originally an emeritus bill, sometimes the past needs to stay in the past. We are considering it to become an emeritus bill now.

SUFAC Chairman Emeritus Schweinert: I would like to ask that all comments are directed towards the Chair.

Parliamentarian Erwin: The arguments against the emeritus status seem overwhelming. The only Chairman SUFAC Emeritus brought up some important points, and so did a Speaker Emeritus. The only difference between this bill and others is the mysterious accomplishments that can't really be spoken about. The Senate can't really deliberate on whether to give emeritus. Maybe in the future when we can speak on it this will change. Every time this title has been spoken about; most people are for it. This time it is not.

Advisor Bilgen: Please raise your hand if you have read 12.5 during the recess. *Advisor Bilgen reads section 12.5 of the Standing Rules*.

Deputy Speaker Petreikis: I think that really speaks to who Chase is. If you read the bill, or all the statements made today, really points towards that.

Sen. Houston: We have a great outline of all the accomplishments Chase has done, and I think that he is more than deserving of Emeritus status.

Speaker Emeritus Wesolek: What does the amendment state?

Parliamentarian Erwin: I believe the amendment was vague.

Advisor Bilgen: I believe that was a question for the Clerk.

SUFAC Chairman Zimmerman: I greatly appreciate you all for taking the past two hours of your life for discussing the emeritus title. I would encourage you all to reflect on what happened here. I am appreciative of the bill. I love my time here, it was good, taught me a lot. I was glad to make the impacts I could make in my little time on campus. If you're a new Senator, and this is your first time seeing an emeriti bill or discussing one. Find your purpose. If your purpose is to fight the standing rules then you're effectively not serving the students. In student affairs you need to find way to bend the rules to best serve the students. That's not saying we don't follow the rules, that's the say we find the best way to support every student on campus, if that means treading the grey area, then tread it happily. If that means you need to consult with the system, if that means you call the higher ups, that means you go through every hoop and round to do that, you do that. IF that means pushing the SUFAC allocation back a week, which rarely happens and obviously indicates a serious issue with hearing an eligibility, then we do that. That is what we are charged to do as student leaders. We do the right thing for everybody in the room. I can say that I didn't agree with everything that the groups are asking, but they are groups nonetheless, and they're students nonetheless, so they have a voice just as much as anybody else does. I was lucky enough to be in a position to direct change. It doesn't matter if you're a Director, on Senate Leadership, the President, you can do whatever you want as a Senator. Sometimes, often, the most powerful position in the room is being a Senator. It is voting on things. So what you all did here tonight, don't forget it. Go home, and be charged with what you just did. Because, it is a good representation of the things we can do, but also if you spend two hours of your life deciding whether or not somebody deserves emeritus status, rather than talking about changes that could actually benefit students. That's the truth, right? It benefits me, I'm a student. But, there are billion other things you could've talked about. A billion other things that I worked on with NALT, and with SUFAC, in conjunction with other folks in the room. If you have an idea, speak out about it and raise some attention, anything could happen Former Speaker Fadness hated the parking, how mean they were, how many tickets he got, so he said hey, I know I don't need to be in the room for this, but I want to be in the room for it. If you're lucky enough to be a Freshman, this is the greatest place to be to start that change. If you're not a Senator, you can do just as much change too. I worked at Homecoming, Warhawk Ambassador, ULead, and I was able to change arguably more lives doing those things, than I did ever arguably as a Senator or in the room. Think of the ways you can be involved and help people who are not in this space. Not spending two hours talking about the interpretation of emeritus members, not spend two hours amending bills. That's not the point of this org. While you do those tings to support people, and rules are important,

but those are not the end all be all. All I have to say, I really enjoyed the spirited discussion, to not get emeritus status, at the end of the day I have been rounded in the work I have been able to do and the change I have been able to affect. In local areas, and in bigger areas, following the first amendment, proper policy, and making sure everybody has a voice. So, thank you so much for the time. Hopefully, your next two bills don't take as long as mine did. Thank you all.
